

PRIVACY STATEMENT PURSUANT

The user's personal data is used by TELEA TECNOVISION S.r.l., which is the data controller, in compliance with the principles of personal data protection established by the GDPR Regulation 2016/679 and the national legislation in force.

METHODS AND PURPOSES OF DATA PROCESSING

1. We inform you that the data will be processed with the following means:

- Mixed - electronic and paper

with the following purposes:

- Fulfillment of legal obligations related to commercial relationships
- Fulfillment of tax or accounting obligations
- Logistics activities as per the Contract
- Processing, printing, enveloping and transmission of invoices
- Supply of the generated service
- Management of Privacy Policy Compliances
- Management of disputes (contracts, orders, deliveries, invoices)
- Customer management (contracts, orders, deliveries, invoices)
- Sending courtesy communications and/or information material
- Websites

In particular, for the purposes specified below the user's data will be processed ONLY on specific acceptance of consent:

- Newsletter and/or sending of commercial communications by e-mail or telephone or SMS or fax
- Profiling activity

LEGAL BASIS

2. The legal bases on which the processing of common data is founded, according to Article 6 of the GDPR Regulation, are:

- Law; Contract; Consent;

The legal bases on which the processing of particular categories of personal data is founded, according to Article 9 of the GDPR Regulation, are:

- Law; Contract; Consent;

The provision of data is mandatory for all that is required by legal and contractual obligations and therefore any refusal to provide them in whole or in part may result in the impossibility of providing the requested services.

The company processes users' optional data on the basis of consent, i.e. through the explicit approval of this privacy policy and in relation to the methods and purposes described below.

CATEGORIES OF BENEFICIARIES

3. Without prejudice to communications carried out in fulfillment of legal and contractual obligations, all data collected and processed may be communicated exclusively for the purposes specified above to the following categories of beneficiaries:

- Supervisory and control authorities;
- Call center for customer support;
- Insurance companies;
- Authorized persons;
- External managers;
- Companies that provide warehouse and transport logistics services;
- Law firms.

Furthermore, some categories of authorized persons and/or internal and external managers identified in writing, to whom specific written instructions have been provided regarding the processing of the data, could acquire your data during their management.

STORAGE PERIOD

The data retention period is: The data will be processed for as long as necessary to carry out the existing commercial relationship and for the following ten years from the date of acquisition of the same.

RIGHTS OF THE INTERESTED PARTY

4. Pursuant to European Regulation 679/2016 (GDPR) and the national legislation in force, the interested party may, according to the methods and within the limits established by current legislation, exercise the following rights:

- request confirmation of the existence of personal data concerning himself (right of access of the interested party - art. 15 of Regulation 679/2016);
- receive intelligible communication;
- have information about the logic, methods and purposes of the processing;
- request its updating, rectification, integration, cancellation, transformation into anonymous form, blocking of data processed in violation of the law, including those no longer necessary for the pursuit of the purposes for which they were collected (right of rectification and cancellation – articles 16 and 17 of Regulation 679/2016);
- right to limit and/or object to the processing of data concerning himself (art. 18 of Regulation 679/2016);
- right of revocation;
- right to data portability (art. 20 of Regulation 679/2016);
- in cases of processing based on consent, receive your data provided to the owner, in a structured and readable form by a data processor and in a format commonly used by an electronic device;
- the right to lodge a complaint with the Supervisory Authority (right of access of the interested party - art. 15 of Regulation 679/2016).

Cookies Information

What are cookies

A "cookie" is a text file saved on the user's computer when the user accesses a website with the aim of providing information every time the user returns to the same site. It is a sort of reminder of the internet page visited. With the cookie, the web server sends information to the user's browser (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) stored on the latter's computer, and will be reread and updated every time the user returns to the site. Depending on their duration, they are divided into session cookies (i.e. temporary ones and automatically deleted by the terminal at the end of the browsing session by closing the browser) and persistent cookies (i.e. those that remain stored on the terminal until they expire or are deleted by the user).

Based on the function and purpose of use, cookies can be divided into technical cookies and profiling cookies.

Technical cookies

Analytics cookies also belong to this category. These are cookies that collect information about a user's use of a website and which allow it to improve its functioning. For example, analytics cookies show which pages are most frequently visited, allow you to check the recurring patterns of use of a website and help understand any difficulties the user encounters in using it.

Profiling cookies

Other cookies can instead be used to monitor and profile users while browsing, study their movements and web browsing or consumption habits (what they buy, what they read, etc.), also for the purpose of sending advertisements for targeted and personalized services. In this case we talk about profiling cookies. The use of these cookies requires the prior acquisition of the user's free informed consent pursuant to art. 7 of EU Regulation 2016/679 and the national legislation in force.

Third party cookies

It may also happen that a web page contains cookies from other sites and contained in various elements hosted on the page itself, such as advertising banners, images, videos, maps or specific links to web pages of other domains that reside on servers other than the one on which the requested page is located. In other words, these cookies are set directly by website operators or servers other than this website. In these cases, we are talking about so-called third-party cookies, which are usually used for profiling purposes. The use of these cookies requires the prior acquisition of the user's free informed consent.

Types of cookies used by our site

The main functions of the cookies installed by <http://www.telea.com/> are technical, they are used to constantly improve the Service, for authentication, for statistical purposes, such as counting visits to the site. The use of cookies is therefore strictly aimed at facilitating the functions of the server while browsing the Service.

The site also allows the sending of the following third-party cookies. These cookies are not tools owned by us, for further information, therefore, it is possible to access the information and the third party consent forms by clicking on the links provided.

To improve the website and understand which parts or elements are most appreciated by users, third-party cookies from Google Analytics are used as an anonymous and aggregate analysis tool.

These cookies are not tools owned by us, for further information, therefore, you can consult the information provided by Google.

The pages of the website incorporate within them some widgets and sharing buttons from Facebook and Google Plus, to allow the user to share the contents of the website on their social channels, and to interact with our channels. These cookies are not tools owned by us, but are created respectively by Facebook and

Some web pages incorporate YouTube video content within them. By visiting a page containing a video, or clicking to view the video, cookies from YouTube may be recalled. These cookies are not tools owned by us. To find out more, visit Google's information page.

Cookie management
